**TAX LEVY ORDINANCE
LISLE TOWNSHIP
ORDINANCE # 2012-4**

An ordinance levying taxes for all town purposes for *LISLE TOWNSHIP, DuPage County*, Illinois, for the tax year 2012 collectible in 2013.

BE IT ORDAINED by the Board of Trustees of *LISLE TOWNSHIP, DuPage County*, Illinois as follows:

SECTION 1: That the sum of: One Million One Hundred Fifty One Thousand Four Hundred and Twenty Dollars (\$1,151,420.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for the following purposes:


