

TAX LEVY ORDINANCE

LISLE TOWNSHIP HIGHWAY DEPARTMENT

ORDINANCE No. LEVY2011

An ordinance levying taxes for all road purposes for LISLE TOWNSHIP HIGHWAY DEPARTMENT, Du Page County, Illinois, for the tax year 2011, collectable in 2012.

BE IT ORDAINED by the Board of Trustees of LISLE TOWNSHIP, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of LISLE TOWNSHIP HIGHWAY DEPARTMENT on December 14, 2011 does hereby determine and declare that the sum of TWO MILLION EIGHT HUNDRED EIGHTY-TWO THOUSAND ONE HUNDRED EIGHT-SIX DOLLARS (\$2,882,186.00) are hereby levied upon all property subject to taxation within the Highway Department as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Highway Department as required by statute or voted by the people in accordance with the law, for such purposes as:

- GENERAL ROAD FUND
- INSURANCE FUND
- IMRF FUND
- SOCIAL SECURITY FUND
- PERMANENT ROAD FUND
- EQUIPMENT & BUILDING FUND

for the year 2011.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Town Clerk shall file with the County Clerk of said County of DuPage, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for LISLE TOWNSHIP HIGHWAY DEPARTMENT.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
