Highway Commissioner Young:

The number of building permits issued by the township is up by 25% so far this year.

The township's auditor is still waiting for the State of Illinois to provide documentation of the motor vehicle fuel tax that was received by the township before it would release the audit. Bill Green then interjected that the township received the documentation just that day and he provided it to the auditor.

Supervisor Tarulis:

The supervisor mentioned that Congressman Peter Roskam had his staff at the township on May 29th to meet with township residents and discuss any matters with which the congressman's office might be able to assist.

Supervisor Tarulis attended a meeting of the DuPage Homeless Alliance on April 28, 2015. He explained to the group how the general assistance program works and how it helps Lisle Township's needy residents. He further noted that the group appreciated the township's efforts and his going out of his way to attend their meeting and explaining the township's programs.

The supervisor held a meeting on the subject of waste hauling on June 9 2015. Only two residents attended the meeting. He then proposed that we place the subject of the waste hauling on the agenda moving forward so that we can meet the goal of having a new contract in place by the end of the year.

The supervisor and board then discussed some of the different ideas for the new contract for a few moments; everyone agreed that we need to add waste hauling to the next agenda so that the project could be moved forward.
