TAX LEVY ORDINANCE

LISLE TOWNSHIP ROAD DISTRICT

ORDINANCE NO. 2019 LEVY

An ordinance levying taxes for all road purposes for Lisle Township Road District DuPage County, Illinois, for the tax year 2019, collectable in 2020.

BE IT ORDAINED by the Board of Trustees of Lisle Township,

DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Lisle Township Road District on November 13, 2019 does hereby determine and declare that the sum of Two Million Nine Hundred Twent Six Thousand five Hundred Dollars (\$2,926,500) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

General Road Fund, Workers' Compensation Fund Illinois Muicipal Retirement Fund, Social Security Fund, Illinois Municipal Retirement Fund Tax Permanent Road Fund and Equipment & Building Fund

for the year 2019.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
