

## LISLE TOWNSHIP ORDINANCE 2019-2

An ordinance levying taxes for all town purposes for Lisle Township, DuPage County, Illinois, for the tax year 2019 collectible in 2020.

WHEREAS, the Supervisor and Board of Trustees have previously adopted a budget for fiscal years 2019 and 2020, and determined the estimated amount of funds to be raised by taxation for the fiscal year 2019; and

NOW THEREFORE, be it ordained by the Supervisor and Board of Trustees of Lisle Township, DuPage County, Illinois as follows:

SECTION I: That the sum of Two Million, One Hundred Eighty-Six Thousand, Six Hundred Forty Dollars (\$2,186,640.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
