An ordinance levying taxes for all road purposes for LISLE TOWNSHIP ROAD DISTRICT, DuPage County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of LISLE TOWNSHIP, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of LISLE TOWNSHIP ROAD DISTRICT on December 27, 2022, does hereby determine and declare that the sum of TWO MILLION FOUR HUNDRED SIXTY FIVE THOUSAND DOLLARS (\$2,465,000) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL ROAD FUND WORKERS COMPENSATION INSURANCE FUND ILLINOIS MUNICIPAL RETIREMENT FUND SOCIAL SECURITY FUND PERMANENT ROAD FUND EQUIPMENT & BUILDING FUND

for the year 2022.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.
