MINUTES OF THE SPECIAL MEETING OF JULY 29, 2020

Discussion of and Potential Action on Lease at 2121 Ogden Avenue for Assessor's Office:

The supervisor then reviewed the situation and conveyed a bit of the boards process regarding coming to the conclusion the selected property was the most appropriate. The property was chosen by the board on the basis that it was the most cost effective, accessible to the public, and fit the township's functional needs. It accomplished this while staying within the parameters set by the electors at a special town meeting.

Assessor Trowbridge and Supervisor Mullen then reviewed a few of the final points in the lease and the board discussed the issue before calling for a vote.
