LEVY-2016

An ordinance levying taxes for all road purposes for LISLE TOWNSHIP HIGHWAY DEPARTMENT, Du Page County, Illinois, for the tax year 2016, collectable in 2017.

BE IT ORDAINED by the Board of Trustees of LISLE TOWNSHIP, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of LISLE TOWNSHIP HIGHWAY DEPARTMENT on November 9, 2016 does hereby determine and declare that the sum of THREE MILLION TWO HUNDRED THREE THOUSAND DOLLARS (\$3,203,000) is hereby levied upon all property subject to taxation within the Highway Department as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Highway Department as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL ROAD FUND WORKERS COMPENSATION INSURANCE FUND ILLINOIS MUNICIPAL RETIREMENT FUND SOCIAL SECURITY FUND
PERMANENT ROAD FUND
EQUIPMENT & BUILDING FUND

for the year 2016.


