

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE No. 08-101

An ordinance levying taxes for all road purposes for LISLE ROAD DISTRICT, Du Page County, Illinois, for the tax year 2008, collectable in 2009.

BE IT ORDAINED by the Board of Trustees of LISLE TOWNSHIP, DuPage County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of LISLE ROAD DISTRICT on December 10, 2008 does hereby determine and declare that the sum of TWO MILLION SEVEN HUNDRED SIXTY-THREE THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$2,763,750) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

-GENERAL ROAD FUND
-INSURANCE FUND
-IMRF FUND

-SOCIAL SECURITY FUND
-PERMANENT ROAD FUND
-EQUIPMENT & BUILDING FUND

for the year 2008.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for LISLE ROAD DISTRICT.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.


