# LISLE TOWNSHIP ORDINANCE 2013-3

DuPage County Clerk

An ordinance levying taxes for all town purposes for Lisle Township, DuPage County, Illinois, for the tax year 2013 collectible in 2014.

WHEREAS, the Supervisor and Board of Trustees have previously adopted a budget for the fiscal year 2013 – 2014, and determined the estimated amount of funds to be raised by taxation for the calendar year 2014; and

WHEREAS, a legal notice pursuant to the Truth In Taxation Act was published, and a public hearing held, prior to adoption of this Ordinance.

NOW THEREFORE, be it ordained by the Supervisor and Board of Trustees of Lisle Township, DuPage County, Illinois as follows:

SECTION 1: That the sum of Two Million, Four Hundred Ninety One Thousand, Two Hundred Fifty Dollars (\$2,491,250.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
