A RESOLUTION TO DETERMINE THE AMOUNT OF MONEY ESTIMATED TO BE NECESSARY TO BE RAISED BY TAXATION FOR THE CALENDAR YEAR 2018 BY THE TOWNSHIP OF LISLE

- The estimated amount of money to be raised by taxation in the calendar year 2018 1. is \$2,466,817.00
- That this Resolution shall be in full force and effect upon its passage and approval 2. as required by law.
